## **Methodology**

#### **Web Survey:**

- Administered Oct. 3-12, 2023
- Non-probability, opt-in panel of U.S. adults 18+
- Total sample: 2,012 including an oversample of 300 Republicans, Republicanleaning independents and conservatives

#### **Research Goals:**

- Measure current levels of trust in U.S. presidential elections.
- Explore factors such as personal characteristics and opinions/attitudes that distinguish conservatives who believe Biden won the 2020 election from those who believe Trump won the 2020 election.
- Basic test of interventions for improving trust:
  - Who is the messenger of election information?
  - What degree of information about election security is shared?

#### **METHODS NOTES:**

- General margin of error is ±2.2 percentage points at the 95% confidence level.\*
- MoE for subgroups are higher.
- Demographic quotas were used to ensure the sample of respondents was broadly representative of the adult U.S. population based on ACS 2021 data.

\*The design effect calculation reflects the post-stratification weights and does not incorporate any model-based calculation of unknown inclusion probabilities. Design effect calculation is based on SRS formula taking into account unequal weighting effect (Kish 1965): n\*(sum of squared weights)/[(sum of weights)\*(sum of weights)]. The margin of error is calculated around a proportion at the 95% confidence level. The maximum margin of error was calculated assuming a reported percentage of 50% and takes into account the design effect as described earlier margin of error calculation: √(0.25/N)\*1.96\*√(DE)






# **2020 Election Beliefs**

# **Conservative Biden**

- Unweighted N = 371
- Republicans/Conservatives
- Independent Republican leaners
- Independent conservatives
- Non-party conservatives
- Who believed **Biden** won or were **unsure** of the 2020 election results

## Liberals/ Democrats

- Unweighted N = 1100
- All Democrats/Liberals
- Independent Democratic leaners
- True independents
- Independent moderates and liberals
- Non-party moderates and liberals

## Which conservatives believe Biden won vs. Trump won in 2020?

#### **Conservative Trump 2020**

- + Slightly more white
- More likely to identify as Republican or Republican leaning
- + "Conservative" Republican
- Political identity is more important to them
- Slightly younger, more millennials
- Moderately or very religious
- + More likely to own a gun

#### **Conservative Biden 2020**

- + College degree
- + "Moderate" Republican
- + Slightly higher income
- + Slightly older: average age of 53 compared to 46 for Trump believers
- + Higher interest in news
- More likely to say they talk about politics to a good mix of Democrats and Republicans
- + More likely to trust local government, Supreme Court, science






## Trust lacking in preventing voter fraud, voter registration obstacles.

#### Rate your level of trust in each of the following:



## There is greater trust of election integrity in-state than out.


#### How much do you trust the accuracy and integrity of elections:

% A lot of confidence




# Conservative Biden believe it's important to accept election results, even if it doesn't go their way.

Generally speaking, I believe it is important to accept the outcome of elections even when my preferred candidate loses.




#### 2 in 5 Americans are concerned a lot about misinformation in elections.


To what extent are you concerned about misinformation in US elections?

When it comes to getting news about politics and elections, which of the following do you rely on? Please select up to 3 sources you use most.








## Most Americans are bracing for an election dispute in 2024.

## Americans are lacking confidence in elections, but in different ways.

#### Conservatives Biden 2020 are concerned about...

- prevention of voter fraud
- prevention of voter obstacles
- Overall, much higher trust in elections than conservatives who believe Trump won in 2020.

#### **Conservatives Trump 2020 are concerned about...**

- prevention of voter fraud
- counting accuracy
- Democrats cheating
- election misinformation

**Less than half** of liberals, independents\* trust completely or a lot that ...

- eligible voters can vote without obstacles
- ineligible voters are prevented from voting




## Only 1 in 5 Americans say no one tried to cheat in the 2020 election.

# **Intervention Experiment**



### **Experiment Methods**

#### **Experiment 1: Testing the messenger.**

- Evaluating trust in the accuracy of elections by who speaks about it publicly.
- Set stage: out-party won 2024 election.
- [INSERT TREATMENT] reports publicly that the election was conducted fairly and the votes counted accurately.
- Treatment conditions:
  - Null: No information about the election fairness or accuracy
  - State election officials
  - Your county election officials
  - Your community's religious leaders
- Post-exposure measure of trust in accuracy of the election.
- Between-subject design.

#### **Experiment 2: Exposure to election security measures.**

- Evaluating trust in accuracy of elections in your state and the U.S. by exposure to verification details.
- Details all the measures taken in [INSERT TREATMENT] to ensure elections are secure and free from fraud;
  - Testing voting machines
  - Storing paper ballots
  - Ballot audit
- Treatment conditions:
  - Null: No information about the election security measures
  - Your state of residence (named the state)
  - The United States
- Post-exposure measure of trust in accuracy of elections.
- Between-subject design.





## **Experiment Results: Even with weak treatment, any exposure helps.**

#### **Experiment 1: Testing the messenger.**

- Overall sample results: no movement in trust.
- Democrats + D-leaning independents: no movement in trust.
- Republican + R-leaning independents:
  - All treatment conditions moved trust compared to NULL for most questions
  - Only from "not at all" to "some + a little" trust
  - Slightly stronger for "county" officials\*

## **Experiment 2: Exposure to election security measures.**

- Overall sample results: exposure to any security measures slightly moved trust in state level elections.\*
- Democrats + D-leaning independents: same as above.\*
- Republican + R-leaning independents: little movement in trust.

Independents excluded from this analysis as there was insufficient sample size of independents by experimental condition for reliable reporting.



<sup>\*</sup> Not statistically significant.

## "The messenger" slightly moved the trust needle for Republicans.

#### The experiment did not significantly influence trust across the sample overall, nor for Democrats.\*
