# OUR WORK, OUR IMPACT, AND HOW OUR THINK TANK MAKES A DIFFERENCE

Last year was characterized by continued political uncertainty and quickly declining trust in many of our major government and civic institutions. That is why the R Street Institute (RSI) spent 2023 showing that our public policy community is critical to reestablishing and safeguarding trust in our communities.

To achieve this, we embraced the **three Cs**—credibility, constructive conflict, and collaboration—and worked to weave them into every part of our organization and the broader policy landscape. These are the values that we, as a think tank, put forth to demonstrate the work that led to our conclusions, investigate our own ideologies and biases, and build new relationships with allies for better, more meaningful collaborations.

When we reflect on 2023, our work speaks for itself: We fought back against **overreach** by the Biden administration; crisscrossed **Capitol Hill** and the country as we promoted a light-touch regulatory approach to **artificial intelligence**; highlighted government policies that undermined **American innovation**; organized our inaugural, standing-room-only **Real Solutions Summit**; and launched our **Red Tape** podcast, which focused on the ways that government bureaucracy can interfere with Americans' daily lives—and so much more.

We're among the best at this work because this three Cs approach is in our DNA: When we opened our doors in 2012, we established our credibility by engaging honestly and seriously on the tough issues of that time. Then, as now, we remain laser-focused on honest, principled, nonpartisan analysis, research, and collaboration. We work with policymakers, think tanks, trade associations, academic institutions, and others spanning the political and ideological spectrums to explore—and provide policy prescriptions for—some of our thorniest policy problems. We frequently testify before **Congress** and **state legislatures**, are featured in **hundreds of news stories** every year, and maintain **high-profile collaborations** across our issue areas.

None of this impact and influence would be possible without stakeholders trusting us and understanding why we take the policy positions we do. That will become even more important this year, as political tribalism and demagoguery continue to upend public trust. This is why our credibility is the most important asset we have: If our supporters do not deem us trustworthy, a think tank focused on public policy research and solutions simply cannot survive.

# COMPETITION POLICY

**The Competition team focuses on everything from health care disintermediation and regulatory reforms to telehealth expansion, outdated alcohol policies, labor and workforce issues, and other burdensome regulations that inhibit innovation and economic growth.**

One of RSI's key [disintermediation](#) projects works to advance contraceptive access at the state and federal levels through reforms such as pharmacist-prescribing models and over-the-counter (OTC) access. Since the Competition team began this project, the [number of states](#) allowing [pharmacy-based access to contraception](#) has [more than doubled](#), and the team has helped stakeholders—including conservative Republicans—in more than a dozen states champion this model. In fact, RSI traveled to a number of states to discuss concerns over contraception policies and scope-of-practice laws. The team also produced a [policy study](#) on the importance of expanding the OTC contraceptive market as well as an [explainer](#) on the similarities and differences of seeing a pharmacist for birth control versus a doctor.

RSI also led the way in advocating for updates to America's antiquated [food and beverage laws](#). Over the past two years, the Competition team has published more empirical alcohol research than any other public policy organization, showing that enhanced alcohol delivery does not correlate with more [drunk driving deaths](#), [alcohol consumption](#), or [underage drinking](#). Their piece about the "War on Restaurants" in *The Wall Street Journal* discussed the progressive crackdown on gas stoves, tipped wages, and attempts to import European sectoral bargaining concepts into the food industry. The team also laid out a flexible worker agenda in the pages of *National Affairs*, positing a pro-worker future for the middle- and working-class labor force in America. An adaptation of this essay also appeared in the March print issue of *National Review*.

# CRIMINAL JUSTICE AND CIVIL LIBERTIES

**RSI's Criminal Justice and Civil Liberties policy program works across the ideological spectrum to engage on public policy that impacts many different facets of the criminal justice system: incarceration, juvenile justice, policing, pretrial, bail system changes, reentry, and sentencing. The team produces research and commentary; conducts outreach to key stakeholders and lawmakers; engages local, regional, and national coalitions; and educates policymakers, the public, and other influencers. Their work is guided by principles that prioritize public safety, due process, individual liberty, and fiscal responsibility.**

In 2023, elected officials and other individuals at every level of government requested the team's expertise, as did groups central to criminal justice research and advocacy. In response to these requests, RSI's scholars met with more than a dozen congressional offices, worked with state officials from Colorado and Washington (among others), and spoke at four times as many conferences, events, and engagements as they did in 2022. These ran the gamut from press conferences to mayoral meetings to policy and practitioner meetings, and more.

The Criminal Justice and Civil Liberties team's work on [policing](#) focused on increasing police legitimacy and enhancing public safety through legislative and regulatory changes to existing law enforcement policies, such as holding police accountable, improving data collection and transparency, promoting the effective use of funds, and addressing police union influence. In addition, the team's efforts on [pretrial policy](#) sought to enhance public safety and protect personal liberty through prosecutorial policies and programs that promote rehabilitation and address root causes with innovative law enforcement response models,

alternatives to prosecution, [bail system changes](#), and mental and behavioral health resources. RSI experts on [reentry and community supervision](#) focused on applying evidence-based practices to improve supervision outcomes and reduce barriers to reentry and full social reintegration. Such work included increasing the awareness of pretrial diversion supervision programs and post-conviction specialty courts, as well as advancing reasonable record sealing and expungement possibilities for those who successfully reintegrate. [Juvenile justice](#) was also a primary area of focus in 2023. The team assessed developmentally appropriate responses to justice-involved youth, which included advancing community-based violence interruption or intervention programs for those with the highest risk of violence; police-led deflection or other system programs that intervene early; individualized treatment; close community supervision; and consistent judicial oversight, among others.

RSI's scholars attended the 2023 National Sheriff's Association event in Grand Rapids, MI.

# CYBERSECURITY AND EMERGING THREATS

The Cybersecurity and Emerging Threats (CSET) policy program at RSI focuses on two critical areas: whole-of-society approaches to enhancing U.S. cybersecurity and bolstering U.S. data privacy and security. Through their engagement in these areas, the team's scholars aim to inform and shape policy action that strengthens cybersecurity, national security, consumer privacy, and the U.S. competitive advantage on the global stage while ensuring that policies support innovation and embrace a limited-government, free-market perspective.

RSI continues to be a leader in the pursuit of comprehensive federal [data privacy](#) policy, which the team showcased through federal testimony before the House Energy and Commerce Subcommittee on Innovation, Data, and Commerce as well as a number of events and briefings. In addition, CSET scholars continued to explore a wide range of issues within privacy policy, examining the role of law enforcement, data brokers, and online child privacy proposals. The team also launched the Cybersecurity Score Project, which highlights the cybersecurity implications of legislative proposals that are not cybersecurity-specific, and was the first right-of-center organization to launch an [Artificial Intelligence-Cybersecurity Working Group](#), bringing together experts from academia, civil society, Capitol Hill, and the private sector. Highlights of the team's recent impact include engaging more than 120 entities on data privacy to find consensus on a comprehensive data privacy and security law, working with dozens of congressional offices on cyber and privacy policy, producing novel written work and research cited by government officials, coordinating nearly 100 diverse cybersecurity leaders to address cyber workforce challenges, and participating in White House and United Nations programs.

# ENERGY AND ENVIRONMENT

The Energy and Environment team seeks to promote a cleaner environment through the combination of a thriving economy, well-founded science, and principles of market competition and limited government. From grid reliability and transmission to the Defense Production Act and rising gas prices, RSI's expertise on electricity and environmental policy has never been more sought after by the media or legislative leaders across the political spectrum.

Last year, RSI's energy work helped set the agenda for many on the right. Important permitting reforms were passed in the Fiscal Responsibility Act (FRA) of 2023 with RSI's influence. In particular, the team's [research](#) and subsequent Hill outreach helped shape the Building United States Infrastructure through Limited Delays and Efficient Reviews Act of 2021, which was folded into Republicans' Lower Energy Costs Act ([H.R. 1](#)) legislation that passed the House. The scholars' [research updates](#) and collaborations with progressive groups also helped secure a bipartisan foundation for FRA negotiations. On the regulatory front, the team's [technical comments](#) were [cited](#) extensively by federal regulators in a new rule that cuts red tape for new power plants, which may help remove some of the biggest barriers to new clean power in half the country. The team also regularly breaks down complicated energy topics for Capitol Hill staff in our "[Low-Energy Fridays](#)" weekly series.

The Energy and Environment team's state work also bore [fruit](#) this year, achieving overwhelming Texas legislative victories to align market incentives to reduce gas flaring and unleash geothermal energy via better-defined property rights. We also helped prevent anticompetitive electric legislation through an analysis series on Texas [SB 6](#), [SB 7](#), and [SB 2012](#).

# FINANCE, INSURANCE, AND TRADE

RSI's insurance program was our inaugural policy area. Over the past decade, legislators, regulators, coalition partners, and industry experts have all come to view RSI as the leader in responding to government overreach in the property and casualty (P&C) insurance industry. As a whole, the Finance, Insurance, and Trade (FIT) team works to address public policy questions that span financial services and free trade, the transfer of risk, and insurance practices in each state.

RSI believes that the insurance industry is the [best-kept secret](#) in the financial services world. The industry plays a critical role in the aftermath of catastrophes, is a significant investor in capital markets, and is the grease in the economy's engine. Without a strong private P&C insurance sector, financial risk would fall on individuals and the government—which is unsustainable, ineffective, and unmanageable. Moreover, a heavily regulated P&C insurance market would have catastrophic effects on all sectors of the economy. Public policy should recognize this and be carefully crafted to take advantage of the value the insurance industry adds to the U.S. economy.

In 2023, the FIT team [testified three times](#) before Congress, helping cement our credibility as an organization that can be trusted to explain the relationship between the insurance industry, the economy, public policy, and outside factors like climate change. By developing insightful policy papers and hosting events on and off Capitol Hill, the team established RSI as a trusted voice on federal crop insurance reform—a nearly \$8-billion-a-year program covered by taxpayers that is [ripe for reform](#). The team's scholars also spoke at major conferences across the country, including those of the American Property Casualty Insurance Association, National Association of Mutual Insurance Companies, M200 Association, Florida Chamber of Commerce Insurance Summit, and Responsible Investor Conference, among others.

# GOVERNANCE

**Governance aims to assess and improve America’s system of self-governance, with a focus on Congress and our electoral system. The program continues its efforts to educate and encourage Congress to properly assert its Article One powers, claw back executive branch overreach, and curb overspending by the federal government.**

In 2023, RSI and the Stavros Niarchos Foundation (SNF) Agora Institute at Johns Hopkins University partnered to travel around the country and bring together more than 100 election officials, election administrators, business leaders, advocates, scholars, and others to help bolster American elections and develop a conservative agenda for democracy. The groups held closed-door gatherings in multiple states, ultimately culminating in a public-facing event in Washington, D.C. where they released a set of [Conservative Principles for Building Trust in Elections](#). (Of note, those principles were echoed by four Republican Secretaries of State and one Lieutenant Governor in *National Review*.)

The Governance team also continued to work across the political spectrum with dozens of coalition allies, Capitol Hill offices, and other experts to cut wasteful spending in the federal government, including bloated [Pentagon projects](#), a red tape-filled [Farm Bill](#), and subsidies for [Big Sugar](#). The team also equipped congressional staff with a deeper understanding of the rules and resources at their disposal to help maximize the power of the “first branch.” All of this occurred as the U.S. House [replaced Speaker McCarthy](#) in October and Senate Democrats considered [nuking Senate rules](#) over held-up military nominations.

# INTEGRATED HARM REDUCTION

**RSI's Integrated Harm Reduction program is grounded in the belief that abstinence-only approaches to risky behavior are ineffective on a population level. The team takes a holistic approach to harm reduction, bringing together historically disparate areas of risk, such as tobacco, cannabis, sexual health, and illicit drug use to advance policy research and propose real solutions to mitigate risk, preserve individual liberty, and ensure public safety.**

RSI's pragmatic approach to policy allows the Integrated Harm Reduction team to find places of consensus and communicate with stakeholders with varying priorities and viewpoints. In 2023, the team was part of the conversation about granting naloxone OTC status, promoted the use of syringe services programs in states across the country, and supported continued access to less harmful nicotine-containing products for adult smokers, among many other harm reduction policy debates.

The team also hosted a standing-room-only expert panel on Capitol Hill to discuss the new era of nicotine and tobacco control, which received rave reviews from key stakeholders, staff, policymakers, and allies. The team's scholars continued to expand the discussion of harm reduction to new, more mainstream audiences, appearing for the first time in *STAT News* (twice)—an outlet read mostly by those in healthcare, pharmaceuticals, and academia. Similarly, the Mercatus Center twice asked RSI scholars to write about substance use for *Discourse Magazine*. Meanwhile, the team's Safer from Harm coalition—which brings together a diverse network of organizations and individuals dedicated to advancing all forms of harm reduction under one public policy banner—added the ACLU, End It For Good, the Center for Black Equity, and Faith in Harm Reduction, among others, to our membership.

# TECHNOLOGY AND INNOVATION

**RSI's Technology and Innovation program champions permissionless innovation, which allows innovators and entrepreneurs the freedom to bring new products to market for the benefit of consumers. While government intervention with new technologies may sometimes be warranted, it should not be a default remedy for fear of the unknown. The team strives to provide an understanding of how digital markets and platforms operate from an economic perspective, as well as evaluate the noneconomic rules and norms required for internet governance.**

RSI believes that artificial intelligence (AI) is a critical new technology with the potential to fundamentally expand productivity and economic growth and that it will be adopted in virtually all sectors of the economy. In this sense, AI may be viewed as the engine of a much larger computational revolution that will offer economic benefits to producers and consumers. The team's goal is to address the potential regulatory threats that may impede the development and deployment of AI-driven technologies.

In 2023, RSI's Technology and Innovation team established itself as a leading voice on [AI policy](#). After making the case for permissionless innovation and providing a thoughtful, balanced perspective on questions around cybersecurity, the team's expertise was requested by legislative committees, congressional caucuses, and individual members of Congress seeking to understand and grapple with this important issue. The team's scholars educated lawmakers and staff at the state and federal levels on ways to [improve children's online safety](#) while upholding First Amendment principles. The team also continued to both lead the debate on the [case](#) for the Federal Communications Commission's [Affordable Connectivity Program](#) (which ensures that households can afford broadband) and challenge the Biden Administration's and Congress' attempts to use government tools to intervene in the free market (which included the Federal Trade Commission's [attack on mergers](#), the misguided [Journalism Competition and Preservation Act](#), and attempts to undo decades of [antitrust](#) and [copyright](#) policy).
